Instructional fees are due by **May 1, 2026**. Payments may be made anytime from enrollment until the due date. Late payments cannot be accepted, and unpaid fees may result in your child being placed on the waiting list.

FINANCIAL INFORMATION

PAYMENT POLICIES

All families **MUST** set up an automatic draft payment plan using the FACTS Tuition Management System and maintain a valid and active account on file. Failure to set up a payment plan will result in your child being placed on our waitlist. **FACTS Tuition Management is the only accepted method of payment for all tuition and fee charges.. The only exceptions are payment in full by grandparents under the special gift tax exclusion and payment in full from a 529 plan.**

Returned Check Fees: There will be a \$30 return payment fee for any returned item charged by FACTS.

Late Fees: A \$45 late fee will be assessed if a payment returns unpaid for any reason.

Suspension for Non-Payment: Students will not be allowed to attend class when their accounts become 30 days delinquent. Students are subject to dismissal if their account is not brought current within one week of their suspension. Student records will not be released until overdue accounts are satisfied.

Scholarship Endorsement: Failure to complete the NCSEAA endorsement by the BCA deadline will result in automatic withdrawal from BCA. Parents are responsible for following up with NCSEAA and ensuring all requirements are met. BCA will communicate the deadline via email at the beginning of each semester.

LATE ENROLLMENT

Students enrolling after May 1 will be considered late enrollees. Upon acceptance, enrollment and instructional fees must be paid immediately. Your child will not be assigned a classroom seat until payment is received and your FACTS Tuition Management account is fully set up with automatic payments. For students enrolling after the start of the school year, tuition will be prorated based on the number of days enrolled.

WITHDRAWAL POLICY

Students are considered enrolled for the full school year, and budgets and teacher contracts are set accordingly. Application, Enrollment, and Instructional Fees are non-refundable. Students who withdraw after May 1 will be charged a \$300 Early Withdrawal Fee. Tuition is prorated based on school days in session. Official transcripts, report cards, and records will not be released until all balances are paid.

PRESCHOOL POLICY

All preschool students must be fully potty trained and not dependent on a pacifier. Diapers, pull-ups, and pacifiers are not allowed due to sanitation guidelines. K3 students must be 3 by August 31st, and K4 students must be 4 by August 31st. A \$35 change fee will be assessed each time a change in schedule is requested after the start of school.

BEFORE AND AFTER SCHOOL CARE

Before School Care (BSC): Available daily starting at 7:00am, not available on any day when there is a schoolwide delay. This program will operate as a drop-in service and students may attend any day for a flat rate of **\$5/day**.

After School Care (ASC): Begins at dismissal and ends promptly at 6:00pm

\$175/month payable in nine payments: First payment September 5 and ninth payment May 5

A set monthly fee is charged regardless of hours used. A non-refundable \$150 per child fee, which covers registration and August attendance, is due at the time of enrollment. Registration opens in August. Students are enrolled for the full school year; withdrawals and withdrawn students may not return for the remainder of the year. Tuition for any month in which a child attends will not be prorated and is billed through FACTS Tuition Management. Late registrants may be accepted only if space allows. ASC is not available on half-days, PD/Teacher Workdays, or school holidays. Pick-ups after 6:00pm incur a \$15 fee for up to 15 minutes and \$5 per minute thereafter. Children who are not enrolled in ASC but are brought to the program will be charged the same rates starting at the end of dismissal.. Habitual late pick-up (more than three) may result in dismissal from the program.
